### 2022 COVID Protocol Information Sheet

#### January 10 Re-Entry

*This is a working document that will adjust as we refine our processes.*

- Students are required to verbally complete the Daily Screening Questionnaire with their family every morning. Do not enter the school if you have answered “yes” to any of the questions.
  
- Students should stay home if they are feeling unwell. If your child has any of the [core symptoms](#), you are legally required to isolate. If they test negative on a rapid COVID test, they must still stay home and away from others until symptoms resolve.
  - For fully vaccinated students and staff (2 doses) who test positive on a rapid test for COVID-19, isolate for five days from the start of symptoms or until they resolve, whichever is longer, if symptoms are not related to a pre-existing condition. For the five days following isolation, wear a mask at all times outside of the home.
  - For students not fully vaccinated (1 dose or less) who test positive for COVID on a rapid test must isolate for 10 days from the start of symptoms or until they resolve, whichever is longer, if symptoms are not related to a pre-existing condition.
  
- Mandatory face masks/coverings **at all times**, except when physically distanced while eating or drinking. No bandanas or buffs. There is no requirement to use the medical masks, but they are highly recommended as they offer a much higher level of protection than non-medical and cloth masks. It is important that the mask fits well to be protective. Students will receive masks supplied by the Alberta government when the school receives the shipment. Each student should receive enough masks for a two-week supply (approx. 20 masks per person).
  
- Each student will be receiving enough rapid tests for approximately 2.5 weeks. Rapid tests should be stored between 2 degrees and 30 degrees Celsius. It is important that students protect the rapid tests from freezing while they are transporting them home. Students will receive rapid test kits supplied by the Alberta government when the school receives the shipment.
  
- Attendance reporting is mandatory. Parents/guardians are asked to notify the school of the reason for student absences as we are required to monitor absence rates due to illness and

report this information to Alberta Health Services. If students enter school late, they must immediately proceed to the main office to check in. After entering, students must go directly to their locker and then their class. If a student must leave during the day, they must check out at the main office prior to leaving.

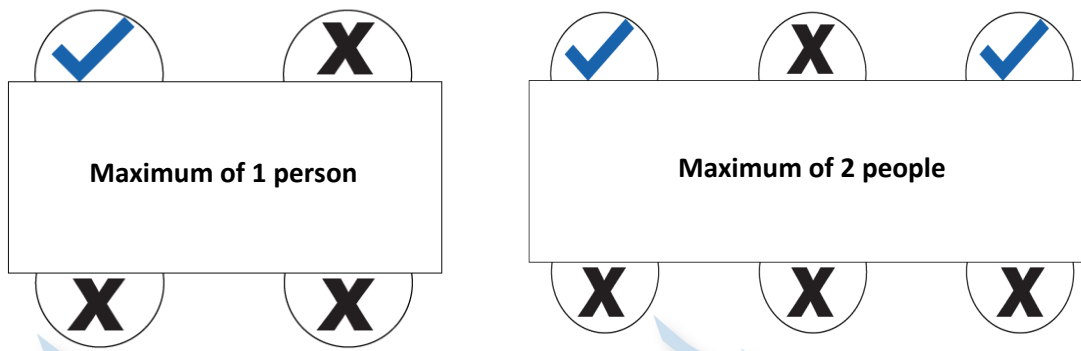
- ❑ Designated Entrances:
  - Grade 10- Main entrance in the front, middle entrance in the back.
  - Grade 11- Entrance south of main in the front, middle entrance in the back.
  - Grade 12- Entrance north of main in the front, entrance by parking lot in the back.
  
- ❑ Congregating at lockers or in the hall still requires physical distancing, but is discouraged.
  
- ❑ Washrooms have occupancy limits. Students must adhere to the limits and wait outside when at capacity.
  
- ❑ Students are responsible for cleaning their areas upon arrival, while eating and when leaving. Students are also required to sanitize hands when arriving, eating, leaving, and entering classrooms.
  
- ❑ Students may leave the school for their lunch break through their designated cohort entrance. Please ensure students maintain physical distancing throughout the break, especially while eating with their mask off.

Students remaining in the school will eat in designated areas:

Grade 10 – cafeteria and North gym

Grade 11 – Banner gym

Grade 12 - mezzanine, Learning Commons, upper floor pods



Students who are NOT SEATED may not remain in the table seating areas around the school. Student wishing to eat with friends must do so in the gymnasiums where they can maintain social distancing while unmasked and eating.

- ❑ To ensure the health and safety of all students and staff, enhanced cleaning protocols are in place at each EIPS school and building—all of which follow provincial public-health guidelines.
- ❑ For the time being, students who are in the learning commons at lunch will need to be seated one student per table. Although students can't congregate, they can use books and materials stored in the library and learning commons.
- ❑ The cafeteria will remain operational with near-normal operations using public-health measures;
  - no sharing of utensils;
  - no self-serve;
  - proper hygiene practices—before, during and after food preparation;
  - ongoing cleaning and disinfecting of high-touch areas.
