Trustee Report April School Council

Sherwood Heights replacement school

- received funding for the planning and design commitment
- we still require the construction funding
- It will remain our number one capital request

Number of budget working sessions held throughout March and April

- Meetings focus: identifying pressures on the system for upcoming year
- Strategic investments in our Four Year Education Plan
- Reviewed feedback from parents, staff and stakeholders in budget surveys
- This feedback informed discussions on how best to leverage reserve dollars in the upcoming school year
- Final decision will be made April 21
- Could see us use \$6.4M from reserves for the upcoming school year
- Board expected to consider budget allocations to schools and departments
- Increases in school fees, system administrative fees and student transportation fees due to rising cost to busing.
- Senior administration is recommending at \$21 increase to all student transportation fee categories

Reserve Fund

- Board to allocate \$1million dollars towards learning achievement gaps
- Not all schools will receive the same amount schools that have already used data to target students (stars results) students needing interventions this money will target.
- Board sent a letter to the Minister requesting a delay in implementation of the new curriculum (K-3 LA and Math & K-6 phys-ed wellness) instead move forward with a second-year pilot.
 - Board received notice from the Minister on curriculum implementation on April 13.
 - Minister hosted a meeting with Board Chair's April 14, they were given opportunity to ask questions and gamin more information
- Board held student forum on April 12
 - Grade 9 and 12 students attended
 - Engaged in discussions on preparing for life after EIPS, Student Mental Health and wellbeing
 - Information gained will inform our strategic approach to preparing students for life beyond high school and student mental health strategic plan
- Trustees will be conducting school tours this spring beginning May 9 at Bev Facey
- International Volunteer week April 24 30
 - Thanks all for having generously given to your schools.
 - This year's theme is Empathy in Action

- The empathy, compassion and generosity of volunteers creates connected communities
- Through your efforts is supporting varying easy for parents to be connected to the school and school decisions has made us stronger as a school division

Questions/discussion from parents

- Around loss of Opportunity Wednesday
- Student Well Being
 - Allocations given to schools have a strategic plan over a 3yr. period of time
 - Some fall inside the mandate of public education but some of the responsibility does not belong to education but other agencies
 - It is a balance, that although schools would like to do it all there are just not enough finances to go beyond what is in the education mandate

FSLW (Family School Liaison Workers)

- Some of our students struggle to get through the door due to issues outside the school
- Even when in person came back, some students stayed online to avoid the in-person learning/ anxiety because they have been out of the school for some time.
- Covid has impacted families and students in a variety of ways elementary more family centered difficulties Jr. and Sr. High seen as family/social issues after being out of the physical in-person learning for so long
- 8. Staff Appreciation Lead Pam Smith Update
 - Raised over \$800.00
 - 3 volunteers to date
 - Call out for more volunteers required
 - Indicate time and volunteer expectations for community

9. COSC (Committee of School Councils) Report - Krista Scott

- Superintendent Mark Ligouri presented about big data and what has happened over time in our province
- Difference between summative and formative assessment data that the district receives
- New Curriculum that is coming and the lack of resources that are there to support and the work ahead for the district to create resources
- Continuum of learning from K-12 and how the data informs these decisions and the journey with the data gaps from the last 3 years
- How to identify the needs of students when we struggle to have the data from the last 3 years
- School council grants update
- Alberta School Council Speaker (Assurance Framework) May 4

10. Review of ASCA Proposed Resolutions - K Tomnuk

- Discussion ensued around the four proposed resolutions
- Krystal Gibson from Salisbury Composite was provided proxy for our vote.

1. 22-01

Request that the Advocacy Policy 20-20 be amended: "That the Minister of Education maintains the weighting of Diploma Exams at 30% for the foreseeable feature." to ".... Extends the weighting of Diploma Exams at 10% in perpetuity."

Arguments to consider:

- pandemic isn't over; 30% is too high of an impact for the students of COVID
- expecting all learners to fit into a one size fits all of a diploma isn't right
- data from province-wide standardized tests can be collected at 10%
- money can be spent writing and marking exams could be spent elsewhere
- exams should not unduly erode instructional time (taught to diploma exams)
- feedback from parents, students and education partners indicate stress and anxiety around academic achievement exams
 - have lowered the weighting in the past
 - acknowledgement by govn't of learning loss in students

Feedback Parents/Administration/Trustee:

- the lower the provincial percentage the more students would opt out of the exam and this can really skew data
- the language of a one size fits all assessment needs to change
- when diploma exams were 50% then lowered to 30%, post secondary schools began looking only at diploma exams for entrance. The lower it falls, the probability more post secondary institutions will look at it exclusively will increase.

VOTE: We DO NOT agree with this resolution : PASSED

2. 22-03

Request that the Minister of Education:

- provide a full and public explanation for decisions to de-fund ASCA and create the 35-member Minister's Parent Advisory Group
- initiate a full consultation into the decision to de-fund ASCA
- reconsider the Minster's Parent Advisory Group
- validate the role of ASCA in supporting school councils by reinstating funding

Arguments to consider:

- defunding ASCA will weaken the collective voice of parents
 - Reduce professional development and training services provided by ASCA
 - Deteriorate the umbrella organization between 1300 school councils and the Minister of Education
 - The Minister's Parent Advisory Group is made up of only 35 parents, instead of equal representation from all parents in Alberta schools
- was announced without consultation with key stakeholders

Feedback:

- parents feel crippled by this resolution
- parent voice is important to schools
- important for ASCA to have a voice

MOTION: We ARE in agree with this resolution: PASSED

3. 22-02

Request that the Minister of Education:

- conduct a policy review of the current infrastructure maintenance funding formula to address deferred issues, ensure schools receive funding for efficient and ongoing maintenance, have safe and healthy schools and remove utilization rates as a factor in funding.
- engage stakeholders in policy review
- work with municipal govn't to coordinate planning

Arguments to consider:

- deferred maintenance has become a challenge for many school boards
- it appears that school-based grants are linked to utilization and ignores consideration of building needs (older schools unfairly penalized, costs increase as maintenance is deferred, etc)

Feedback:

- arguments presented are not accurate such as municipalities having input into school planning and the proper stakeholders have not been identified in the policy review
- the funding required to do this this seems like an unreachable ask
- the funding model for a rural area is very different than that of a large metro area (where this proposed resolution is coming from)
- All EIPS schools have deferred maintenance to some degree
- To wipe out all of it financially is not realistic but certainly could ask and have it addressed in a more timely manner

MOTION: We are NEUTRAL in agreement with this resolution because we believe the resolution will be picked apart and won't be as presented when it comes time to vote: **PASSED**

4. A22-01

In order to be compliant with ASCA's policy to reaffirm or amend a policy that hasn't been changed after its 10th anniversary but is still considered relevant

12-2 High Risk Bus Stop Awareness and Signage

That Alberta Education and Alberta Transportation collaborate to develop universally recognized signage and make this signage available to school boards to be placed at higher risk bus stops.

That Alberta School Boards Association develop a policy advisory to ensure that school boards across the province have information relevant to appropriate steps that may be taken to ensure student safety at high risk school bus stops.

Rationale

 Directing operations of an education partner is ineffective advocacy and ASCA's advocacy efforts should be focused on the ministerial level.
